**Brandeis and the Progressive Constitution** Edward A. In an analysis of the continual reconceptions of both Brandeis and *Erie* by new generations of judges and scholars in the twentieth century, Purcell also illuminates how individual perspectives and social pressures combined to drive the law's evolution.
